Perceptual Evidence

Course Description

This seminar will address the following set of questions: What evidence does perceptual experience provide us with? What is the rational source of perceptual evidence? What role (if any) do sensory states play in perception yielding evidence? What is the relationship between perceptual evidence, knowledge, and justification?
